Declaration of conformity - to come into contact with food

The products delivered :

**HD.PE 15 MU transparent
HD015300400**

Intended use :

Packaging for wet, dry and greasy food. Any long-term storage at room temperature or below (-20°C) including calefaction at the maximum of 60°C for max. 2 hours.

Surface-to-volume ratio : 6

The product complies following legislation :

- * Regulation EG/1935/2004
- * Regulation 10/2011/EU
- * Regulation 2023/2006/EG
- * Directive 94/62/EG

Overall migration :

The overall migration limit will be adhered to regulation 10/2011/EU. The overall migration is less than 10 mg/dm². The migration tests were carried out in accordance with regulation 10/2011/EU Art. 22 (1) and the annex of directive 82/711/EEG. The noted tests for the mentioned intended-use are compliant with regulation 10/2011/EU.

Simulants :

- A : Ethanol 10%
- B : Acetic Acid 3%
- D2 : Vegetable oil (Olive oil)

Test conditions :

OM2 : 10 days at 40°C

Substances with specific migration limit (according to 10/2011/EG) :

The product contains substances with specific migration limit (SML), even though in a such small amount that the SML value will not exceed the limit even in case of complete migration. (worst-case-calculation)

Dual Use Additive

Since there is no full, legally directory to this group of substances, we point out that the specification of dual use additives may be incomplete.

Due to the magnitude of the limits for these substances compared to the limit of global migration (60mg/kg or 10 mg/dm²), it is very unlikely that a dual used as plastic additive endangers the compliance of these limits. The following dual use additives can be included :

E170, E171, E290, E291, E330, E432, E470a, E551, E553b, E559, E570, E1512

A functional barrier is not included.

It is expressly pointed out that any contact between printing ink and food must be avoided (only for printed goods). The printing inks used, are in accordance with the EuPIA Guideline "printing inks applied to the non-food contact surface of food packaging and articles".

These statements exclusively refer to the products mentioned above as they leave the factory. Any usage of the product concerning the filling material that goes beyond the described intend use has to be proofed by the user on his own responsibility.
